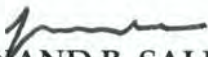

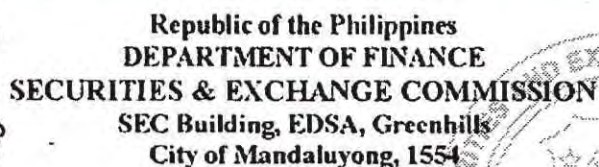

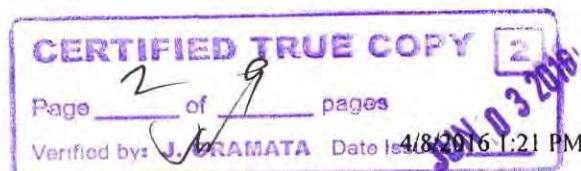

We, the members of the Board of Trustees of the The Philippine Christian Foundation, Inc., located in Smokey Mountain Reclamation Development Area (SMRDA) Brgy. 128 Paradise heights Rd. 10, Balut Tondo Manila 010, in order to carry out effectively and faithfully the administration of the THE PHILIPPINE CHRISTIAN FOUNDATION, INC., do hereby ordain and promulgate these Articles.

THAT WE HEREBY CERTIFY

FIRST: The name of the association shall be

SECOND: That the purpose or purposes for which such association is incorporated are:

THIRD: That the place where the principal office of the association is to be established at:

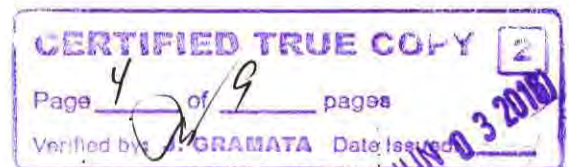

EIGHT: That no part of the income which the association may obtain as an incident to its operation shall be distributed as dividends or remuneration to its members and trustees, even if serving as corporate officers, and the level of administrative expenses shall not exceed thirty percent (30%), of the total donations received nor the total expenses for any taxable year. In the event of dissolution, all the remaining assets of the Foundation shall be passed on, in the following order of priority, to PCNC accredited NGO or organization of similar purpose or purposes, or to the state to be devoted for the same purposes, subject to the provisions of the Corporation – Code on dissolution; Any profit obtained by the association as a result of its operation, whenever necessary or proper shall be used for the furtherance of the purposes enumerated in Article II subject to the provision of Title XI of the Corporation Code of the Philippines.

NINTH: That ALEX BARCELLANO has been elected by the members as Treasurer of the association to act as such until his/her successor is duly elected and qualified in accordance with the by-laws; and that as such Treasurer, he/she has been authorized to receive for and in the name and for the benefit of the association all contributions or donations paid or given by the members.

TENTH: That the association manifest its willingness to change its corporate name in the event another person, firm or entity has acquired a prior right to use the said firm name or one deceptively or confusingly similar to it.

ELEVENTH: That the association shall comply with the requirements for non-stock corporations in the course of its operation.
