AMENDED ARTICLES OF INCORPORATION

OF

COASTAL CONSERVATION AND EDUCATION FOUNDATION, INC. (Formerly Sulu Fund for Marine Conservation Foundation, Inc.) (As amended on Feb. 6, 2002) Name of Corporation

KNOW ALL MEN BY THESE PRESENTS:

The undersigned incorporators, all legal age and a majority of whom are residents of the Philippines, have this day voluntarily agreed to form a non-stock, non-profit corporation under the laws of the Republic of the Philippines. (As amended on February 24, 2012).

AND WE HEREBY CERTIFY:

FIRST: That the name of the said association shall be:

COASTAL CONSERVATION AND EDUCATION FOUNDATION, INC. (Formerly Sulu Fund for Marine Conservation Foundation, Inc.) (As amended on Feb. 6, 2002)

SECOND: That the purpose or purposes for which the corporation is incorporated are:

- To promote the protection, management and sustainable use of Philippine coastal 1. resources through the active leadership and participation of coastal resource users, local governments, non-government organizations, academe and other stakeholders. (As amended on February 6, 2002).
- To promote and undertake community, local government and private sector based coastal resource management approaches, in specific coastal areas. (As amended on February 6, 2002).
- To promote and build leadership capacity for improved coastal resource management through training and learning by doing. (As amended on February 6, 2002).
- 4 To conduct research and disseminate the results on coastal environment, socioeconomic systems and governance of coastal resources and areas to promote improved awareness and knowledge for effective coastal resource management. (As amended on February 6, 2002).
- To provide an information base on coastal environment and its governance that is easily accessible and provides guidance for improved coastal management. (As amended on February 6, 2002).
- To engage in fund raising activities when necessary to carry out the purposes of the organization, but no profit shall be distributed to the members whether in cash or in kind. (As amended on February 6, 2002).

THIRD: That the specific principal office address of the association is at Room 302 PDI Condominium, Archbishop Reyes, Avenue, Barangay Banilad, Cebu City, Philippines (As Amended on February 24, 2017);

FOURTH: That the term of the association is extended for another (25) Twenty Five Years from January 20, 2023 the expiry date of the original incorporation. In the event of dissolution, the remaining property or assets shall be donated to another corporation with the same or similar purpose or to the government of the Philippines. (As amended on February 23, 2018

(As amended on February 24, 2017).

ELEVENTH: That the association shall comply with the requirements for non-stock and non-profit corporations in the course of its operation. (As amended on February 24, 2017).
